You include them every time you quote or paraphrase someone else's ideas or words. An APA in-text citation consists of the author's last name and the year of publication (also known as the author-date system).

In APA referencing, you can cite an unpublished work in the same way as you would a published one. This means giving an author's name and a date in brackets. The only difference is that you give a year of production (i.e., when the paper was written) rather than a year of publication: Few fully understand the publication process (Clarke, 2020).

Academic papers in APA citation has general writing guidelines. Papers should be typed, double-spaced on standard-sized paper (8.5" x 11") with 1" margins on all sides. You should use a clear font that is highly readable. APA recommends using 12 pt. Times New Roman font.
